Ted- suggest moving forward with approving these classes and reach out to AA about what they are developing as an official policy. Then can work with Beth to see if there is language we could suggest, consistent with official policy, that we can push out to all Gen Ed classes.

Carolyn- keep in mind that appropriate use of AI can be discipline-specific

The spreadsheet has a place for notes for each class and Ted asks that the FCCs add their comments to that spreadsheet to facilitate discussion by Gen Ed Council if needed as well as for communicating with departments. If FCC's need clarification in regards to a renewal, they are asked to reach out to contact person in department directly (as indicated in spreadsheets) and cc Ted.

-Assessment activities for the 2023-2024 academic year – committees have completed work on updating rubrics for Goal 1 (Thinking critically and creatively) and Goal 2 (Communicating effectively). Will be working on rubrics for Goal 3 (Making local to global connections) and Goal 4 (Understanding responsibilities of community membership) during spring semester.
