Dr, Zerucha updated members of the status of renewals for this year, which are due on the Monday after Thanksgiving (I1/28/22). Renewals are beginning to come in. Ted asked for preference of committees receiving the renewals as they come in, or holding until the deadline – preference was stated to receive as they come in. Ted asked committees to keep an eye out for exemplary ones that can be posted on the website as examples.

Dr. Zerucha gave a review/update on the Gen Ed Revision Task Force for new members. The task force submitted their final report to the provost over the summer with recommendations based on the listening sessions: 1) reduce hours of the Gen Ed program; 2) establish a Sustainability/Climate requirement; 3) establish a Diversity/Multi-Cultural requirement; 4) consider a Financial Literacy requirement. The Task Force was unable to create a plan that both cut hours and created three new requirements, but they did include a plan in the report to cut Gen Ed hours and include a Sustainability/Climate and a Diversity/Multi-Cultural requirement. The provost has requested to revisit the feasibility of a Financial Literacy requirement. A committee has been formed that includes faculty teaching these types of courses to work on this {Ted Zerucha, Mark Ginn, Angela Brown (Curriculum & Instruction), Katrina Palmer (Mathematical Sciences), Kevin Huff (Finance, Banking & Insurance), Dave McEvoy (Economics)}. This committee will bring their recommendations back to the provost.

Members were reminded that the next Gen Ed Council meeting will be held on December 2nd.

There being no further business, the meeting was adjourned at 3:50pm.
